In anticipation of the upcom- Commuters not attending the ing India International Trade Fair set to take place at the Pragati Maidan here from November 14 to 27, Delhi Police have released a traffic advisory to apprise the public of the potential congestion on specific routes in the national capital. With daily attendance of approximately 40,000 visitors, ne numbers are projected to surge to around one lakh visitors per day on weekends and holidays. As per the guidelines, commuters have been urged to take note of the advisory to navigate the city's roads effectively during the two-week-long event. Marg, Ring Road, Sher Shah Commuters not attending the trade fair are strongly urged to avoid these routes to ensure smooth journey. The IITF, scheduled from November 14 to 27, will enforce a phased entry system. Business visitors will be allowed entry from November 14 to 18 , followed by general public from November 19 to 27 . The advisory specified designated entry gates for the visitors, exhibitors, mediapersons, and India Trade Promotion Organisation
(ITPO) officials. The visitors with personal vehicles are directed to utilise the designated parking facilities, including basement parking No. 1 (entry and exit from Bhairon Marg) Bhairon Mandir parking on Bhairon Road, and Delhi Zoo parking.


## Maurya clarifies remarks on Goddess Lakshmi

Lucknow, Nov 15 (IANS) After creating a furore with his statements, Samajwadi Party (SP) leader Swami Prasad Maurya has clarified that his controversial comments on Goddess Lakshmi, saying they are of a practical nature, based on truth, scientific and not hinged on someone's imagination"
Maurya had questioned how Goddess Lakshmi could have four arms because no such person is born like this. In his clarification on Wednesday, the SP leader said: "I had not spoken about four arms alone, I also spoke about eight arms, 10 arms, 1,000 arms - no such child has ever been born in the country. If it did happen, I challenge them to tell me and
will accept it. "We can make somebody with $1,000 \mathrm{arms}$ or 20 arms or 10 arms on the basis of our imagination. Imagination is just imagination. I said what is practical based on truth scientific and Sanatan too. I also spoke as per Sanatan Dharma and I said that people must respect their wives as she is the 'Grih Lakshmi' in the real sense."

should condemn him everywhere he goes." Explaining the reason for Goddess Lakshmi having four hands, the head priest said that he deity is "four-handed as she is from the dynasty of 'rakshas'".
Satyendra Das said that Maurya is deaf and ignorant and there is no use of speaking to him. "He is deaf. Whatever you say, it does not have any effect on him. He will be punshed... Since he is ignorant, nothing can be said about him
